The reason for the single invitation is that we must submit your application to the Office of the Public School District by January 15, 2018. **Therefore, any applications received after the Thursday, January 11 deadline, cannot be accepted.**

A section of Nebraska law allows parents of students attending approved non-public schools to request the loan of textbooks from the Public School District in which their non-public school is located for their student to use in the non-public school s/he attends. The number of books available to be borrowed depends on the funds allocated by the Nebraska unicameral, not the local Public School District.
