REGISTRATION FEE – A registration fee of \$350 per student is due each year at registration time. The registration fee will be due when you select your payment plan on the FACTS website after you receive the online invitation from FACTS. ***Registration is NOT considered complete and a spot will NOT be saved for your student until the \$350 fee is received.***

PARISH SUBSIDY – In addition to tuition, the Archdiocesan parish where you are an active registered member is assessed \$400 to help with the cost of educating your student. Skutt Catholic will contact your parish to collect this subsidy. (Please thank your pastor for this financial commitment to your student’s education).

NOTE: Parishes pay this assessment according to their own guidelines and criteria. If your parish declines to pay, the assessment becomes the family’s responsibility and you will be invoiced \$400 at the time that Skutt Catholic is notified by the parish. If you are NOT registered with an Archdiocesan parish, the \$400 will be invoiced along with tuition at the start of the school year.

TECHNOLOGY FEE – A \$350 technology fee will be assessed to all students at all grade levels. The technology fee covers the cost of providing a school-owned iPad for the student’s use and the technology required throughout the school to support the iPad program. The iPad will be turned back in to Skutt Catholic at whatever point a student is no longer enrolled (e.g. withdrawal or senior graduation) and/or whatever time Skutt requests the device be returned and replaced by a new device with upgraded technology. There is not an option to bring your own device.

TUITION ASSISTANCE / WORK STUDY – The FACTS Grant and Aid Assessment Application may be accessed directly at www.factstuitionaid.com or via www.skuttcatholic.com. **The online application must be submitted by February 28th and supporting documentation must be submitted by Monday, March 18th, 2019 to be eligible for maximum aid.** Please allow 2-4 weeks for FACTS to process your completed application and for Skutt Catholic to communicate an award amount to the family. We will work with each family to review demonstrated financial need. It is our desire that no student will be prevented from attending Skutt Catholic due to financial hardship. Students who qualify for Tuition Assistance will participate in our Work Study program. Please contact Kristen Reeves with any Work Study questions.

Financial Aid Awards will be first distributed to families who have followed the deadlines of the program. Any applications or verification documents submitted after the deadline will be considered for secondary rounds of aid but will not receive as much aid as a similar family who applied within the deadlines.

PAYMENT PLANS – After registering for the 2019-2020 school year through the Infinite Campus Registration, you will receive an email from the FACTS Management System that will ask you to choose a payment plan for your tuition & fees for the year. This payment portal will allow you to set up your payments with either a check, ACH withdrawal or with a debit or credit card. **Please note any credit or debit card payments made will be assessed a 2.85% surcharge that is paid by the family.**

Option 1: Annual – Due August 1st (or July 1st if you would like to take advantage of a \$100 discount)

Option 2: Semi-Annual – Payments are due July 1st and January 1st

Option 3: Quarterly – Payments are due July 1st, October 1st, January 1st & April 1st. **

Option 4: Monthly - 12 Months – Payments are due on the 17th of each month over 12 months beginning with June 17th and ending the following May 17th. **

Option 5: Custom Plan – Custom payment plans can be created for your family including the ability to create payment plans that coordinate with pay dates either weekly or bi-weekly. For custom payment plans, please contact Taryn Clatanoff directly. **

*** Payment plans with more than 2 payments require automatic ACH withdrawal or credit / debit card payments to be set up within FACTS.*

Skutt complies with IRS regulations for cash payments in excess of \$10,000 in a single or related transaction.

PAYMENT NOTES – Families that pay in full by July 1st qualify for \$100 discount which can be deducted from the annual tuition payment OR the \$100 becomes a tax-deductible contribution to our scholarship and financial aid fund. Annual and semi-annual tuition payment options have the option to be set up via an electronic invoice or through automatic ACH, credit or debit card payments. The quarterly, monthly & custom options require an automatic ACH, credit or debit card to be set up within the system.

WITHDRAWALS – If a student withdraws during the school year, the balance owed by the family or the tuition overpayment that is refunded will be determined on a prorated basis. Registration fees are non-refundable. Technology Fees are prorated on a per semester basis.

DELINQUENT TUITION – Skutt Catholic relies on the prompt payment of tuition in order to meet our financial obligations. Delinquent tuition accounts are reviewed monthly and if satisfactory payment arrangements are not made, a student may be dropped from enrollment.

LATE FEES – Fees for late payments will be assessed at \$30 per late payment. Returned Item Fees will be assessed at \$30 per returned item and will be re-attempted twice with no additional charges after notification from your bank or credit card institution of a failure to process.
